- The subject proposal is requesting permission for laying of underground 1). Optical Fiber Cable (OFC) along the NH-544 by Open Excavation of 40mm Dia HDPE pipe from Km 4/900 to Km 10/700 (RHS), Km 15/900 to Km 18/100 (RHS) & Km 18/900 to Km 20/200 (LHS) and across the road by HDD Method of 100mm Dia Casing pipe at Km 4/900 in the project of Salem - Kumarapalayam section of NH-544 in the State of Tamil Nadu.
