**INVITATION OF PUBLIC COMMENTS**

Sub:- NHAI-RO Kerala-Six Laning of Thalikulam to Kodungallur section from Km.369.015 to Km.397.850 of NH-66 (Old NH-17) in the State of Kerala on Hybrid Annuity Mode under Bharatmala Pariyojna-Accommodation of Public and Industrial Utility Service along National Highways-Laying of 11 KV UG Cable(3x300 Sqmm Cable) through HDD by KSEB from Km.384+200 to Km.384+500(RHS) of existing NH-17(New NH-66)-Reg.

The proposal is regarding permission sought by KSEB for laying of 11 KV UG Cable(3x300 Sqmm Cable) in the subject project location in the State of Kerala.

2. KSEB has furnished undertaking to bear all expenditure, if any, incurred by NHAI for repairing any damage caused to NH by laying, maintenance or shifting of UG cable. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, KSEB has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. KSEB has also undertaken to manage traffic movement during the execution of the work.

4. In addition, KSEB has also undertaken that they will shift the utility within a period 60 days of intimation by NHAI, for carrying out widening, improvements and repairs of National Highway.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by KSEB will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
