Invitation of public comments

Subject:- Permission proposal for laying of underground water pipe line along the road from Km 56/639 to Km 60/600, Km 60/644 to Km 61/248, Km 61/480 to Km 62/435(RHS) and from Km 59/954 to Km 60/300, Km 60/644 to Km 61/248, Km 61/480 to 62/259(LHS) of NH-49Extn(New NH-85)(Madurai Cochin road) for improvement of water supply scheme to Aundipatti Town Panchayat in Theni district in Tamil Nadu state under Amrut 2.0-Reg.

The proposal is regarding requesting permission for laying of underground water pipe line along the road from Km 56/639 to Km 60/600, Km 60/644 to Km 61/248, Km 61/480 to Km 62/435(RHS) and from Km 59/954 to Km 60/300, Km 60/644 to Km 61/248, Km 61/480 to 62/259(LHS) of NH-49Extn(New NH-85)(Madurai Cochin road) in Tamil Nadu state by the Executive Officer, Andipatti Town Panchayat Theni submitted to this office by the SE (NH), Madurai vide letter No.790/2025/JDO-2/ dated 03.04.2025. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying Water pipe line is from 14.20m to 31.70m. The carriageway width of stretch from Km 56/639 to Km 60/600, Km 60/644 to Km 61/248, Km 61/480 to Km 62/435 of NH-49Extn(New NH-85) is 10.20m. The Executive Officer, Andipatti Town Panchayat Theni has proposed to lay the underground Public Utility at edge of the ROW for a length of 4269m by adopting open trench method along the National Highway.

3. The Executive Officer, Andipatti Town Panchayat Theni has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Officer, Andipatti Town Panchayat Theni will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
