## INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Six laning of Existing Kozhikode Bypass (i.e. Vengalam Jn. to Ramanattukara Jn.) from km 230.400 to km 258.800 (Design Chainage) of NH-66 in the State of Kerala under NHDP Phase-III on Hybrid Annuity Mode -Laying of 11 KV UG cable 3x240 Sqm with 102 mm HDPE pipe casing from Km.253+370 to Km.253+560(LHS) by M/s The Deshabhimani Printing & Publishing House Ltd., Kozhikode on NH-66-Reg.

The proposal is regarding permission sought by M/s The Deshabhimani Printing & Publishing House Ltd., Kozhikode for laying of 11 KV UG cable 3x240 Sqm with 102 mm HDPE pipe casing from Km.253+370 to Km.253+560(LHS) on NH-66 in the subject project stretch in the State of Kerala.

- 2. M/s The Deshabhimani Printing & Publishing House Ltd., Kozhikode has furnished undertaking to shift the UG cable at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the Applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, M/s The Deshabhimani Printing & Publishing House Ltd., Kozhikode has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. M/s The Deshabhimani Printing & Publishing House Ltd., Kozhikode has also undertaken to manage traffic movement during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s The Deshabhimani Printing & Publishing House Ltd., Kozhikode will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
