Invitation of public comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s HPCL at Ch.750/697 to Ch.750/740 (RHS, Khasra No. 6787 & 7021/6788) on NH-27 at Village-Jaswantgarh, Tehsil-Gogunda & District- Udaipur in the State of Rajasthan.

M/s HPCL ie. the applicant vide letter No.UDRO/AK/JASWANTGARH/UDAIPUR dated 26.12.2019 received in this office dated 03.02.2020 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. The proposal was forwarded to PD NHAI PIU-Udaipur vide this office letter 04.02.2020 for comments and factual report. PD NHAI PIU-Udaipur vide letter No. NHAI/UDR/HPCL/P-U/750+697/2630 dated 12.03.2020 has submitted the required. The proposal falls on Median opening at 238.08m from proposed fuel station. Therefore, this office has directed PD to re-examine the proposal and extend the service road beyond median opening which is 238.08m. Accordingly, PD got the proposal revised and has examined the proposal accordingly and recommended the same mentioning that Oil company will construct service road of 379m long and 5.5 m wide and Also Oil company has submitted an undertaking to extend (construct and maintain) minor culvert falling in service lane. Service road and extension of Minor culvert will be constructed and maintained by Oil Company at their own cost. Undertaking for the same is appended with the proposal, therefore, this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per Form A (copy enclosed) on below mentioned address.
