INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Four laning of Thiruvananthapuram bypass from Kazhakuttam-Mukkola (Km.0+000 to Km.26+500) section of NH-47(New NH-66) under NHDP Phase-III in the State of Kerala-Laying of 11 KV HT UG Cable for giving HT supply to M/S Legoon Retreats Pvt Ltd. from Km.18+850 to Km.19+020 RHS in Thiruvananthapuram Bypass-Reg.

1 The proposal is regarding permission sought by KSEBL for laying of 11KV HT UG cable from Km.18+850 to Km.19+020 (RHS) on NH-66 in Thiruvananthapuram Bypass in the subject project stretch in the State of Kerala.

2. KSEB has furnished undertaking to shift the underground OFC cable at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same within 60 days from the date of receipt. Further, the applicant has undertaken for payment of rent/fee and to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.

3. Further, KSEBL has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. KSEB has also undertaken to manage traffic movement during the execution of the work.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by KSEB will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
