

### Invitation of Public Comments

**Sub: Permission for applying 8 inch Steel Gas Pipeline along with OFC for City Gas Distribution Project along and across NH-33 at following location: Reg.**

(i) Across NH-33 between NHAI Km Stone 81-82 (Km 81+716), 69-70 (Km 69+78) and 56-57 (Km 56+750).

(ii) Along NH between Km 89+685 to Km 41+560.

(iii) Installation of Isolation Valves in Valve Chambers along NH-33 between Km 41+560 to 89+685.

Project Director, NHAI, PIU-Ranchi vide letter dated 23.11.2021 has forwarded the proposal of M/s Indian Oil Corporation Limited with recommendation for issuance of No Objection Certificate for laying 8 inch steel gas pipeline along with OFC for City Gas Distribution Project along NH-33 from Ch. Km. 41+650 to Ch. Km. 89+685 & across NH-33 at Ch. Km. 81+716, 69+780, 56+750 for Ranchi City Gas Distribution Work.

As per Ministry circular issued vide OM no. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration shall make available the proposal for granting license for use of National Highway land for laying utility service for public comments for 30 days on ground of public interest.

With reference to above mentioned email wherein NHAI, HQ has requested to furnish the information / clarification for issuance of revise sanction letter for shifting of utilities of underground water pipeline for an amount of Rs. 3.84 Cr. of the subject project. The details of information / clarification are as follows:-

		<p>pertinent to inform that one number VUP at Ch. 375+830 has not been started due to public protest. They want to construct flyover with pier construction as this is market area. The work has been started in June' 21 and September' 21 after sanction by RO, Ranchi and before the issuance of PCOD i.e. 09.10.2021. Water supply utility work are in progress. Work of service road in the village of Topchanchi (proposed service road along the RE wall of VUP at Ch. 375+831) is in progress.</p> <p>Cost of shifting in original sanction of project Rs. 32.18 Cr. Hence Rs. 36.02 Cr. (Rs. 32.18 Cr. + Rs. 3.84 Cr.) is required for approval by competent authority.</p>
