Sir,

This has reference to the letter mentioned at Sr. No. (i) vide which Project Manager, JUIDCO Limited has submitted the proposal for issuance of NOC for laying of pipeline on NH-31.

- This office vide letter under reference (ii) has requested to Authority Engineer-M/s Lion 2. Engineering Consultant Pvt. Ltd. to examine as per relevant circular/guidelines issued by Ministry/NHAI and submit report alongwith recommendation.
- The Authority Engineer M/s. Lion Engineering Consultant Pvt. Ltd. vide letter under ref.(iii) 3. has recommended the proposal with conditions i.e. the JUIDCO may undertake the work in consultation with the EPC Contractor at the section where ROW (Utility Corridor) is available as land acquisition work is in progress, the work shall be executed as per NHAI Policy guidelines.
- The full width ROW is not available at this juncture, but CALA has issued possession certificate but amount of compensation is pending in many places. Accordingly, as and when ROW (full width) will be available, JUIDCO may carry out this work.

Considering the above, as per the submission of the Authority Engineer - M/s Lion Engineering Consultant Pvt. Ltd., the subjected proposal as submitted by the Project Manager, JUIDCO Limited is hereby forwarded with the condition that the work will be executed when/where acquired land (Full width of ROW) will available for work. Accordingly, recommended for your kind perusal and further necessary action towards approval.
