Sub: NHAI – PIU, Salem – Proposal for laying of underground Optical Fiber Cable (OFC) by HDD Method along 3the NH-68 from Km 81/200 to Km 81/800 (RHS) – 600m, Km 92/600 to Km 92/900 (RHS) – 300m, Km 97/200 to 97/400 (RHS) – 200m and across the road by HDD Method at Km 81/800 – 60m, Km 92/600 – 60m by M/s Telesonic Networks Limited, Chennai - Approval requested – Reg

- 1). The subject proposal is requesting permission for laying of underground Optical Fiber Cable (OFC) along the NH-68 (New NH-79) by HDD Method of 80mm PLP pipe from Km 81/200 to Km 81/800 (RHS) 600m, Km 92/600 to Km 92/900 (RHS) 300m, Km 97/200 to 97/400 (RHS) 200m and 150 mm dia RCC casing line by HDD Method across NH at Km 81/800 60m, Km 92/600 60m in the project of Salem Ulundurpet section of NH-68 in the State of Tamil Nadu.
- 2). M/s Telesonic Networks Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
