**Sub:** NHAI - PIU, Salem - Proposal for laying of underground Optical Fiber Cable (OFC) by open excavation of 40mm Dia pipe along the NH-7 from Km 228/100 to Km 230/200 (RHS) and across the road by HDD Method at Km 230/200 - 60m by M/s Telesonic Networks Limited, Chennai - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of underground Optical Fiber Cable (OFC) along the NH-7 by Open Excavation of 40mm Dia PLP pipe from Km 228/100 to Km 230/200 (RHS) - 2100m and 150 mm dia RCC casing line by HDD Method across NH at Km 230/200 - 60m in the project of Salem - Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). M/s Telesonic Networks Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Telesonic Networks Limited, Chennai will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
