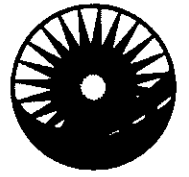

Please refer to the letters cited above. Feasibility of the proposal with respect to available ROW on the stretch of NH along which the project is proposed to be executed has been checked with the GAIL's representative on site dated 03.02.2021. The project length is 10745m (including crossings). The proposal was found suitable for execution of the project.

Accordingly, the license fee amounting Rs.30,47,260/- was calculated as per MoRT&H circular dated 22nd November, 2016. The rate taken for calculation of license fee has been provided by Registrar, Chandil vide letter u/r (i). BG amounting Rs.10,75,500/- has to be submitted by the utility service provider as per MoRT&H circular dated 22nd November, 2016 i.e Rs.100/meter.

In view of above, the proposal is forwarded herewith duly recommended for approval of the Competent Authority.
