- 3) Executive Officer, TWAD Board, Project Division, Valliyoor has proposed for laying of water pipe line along Madurai Kanyakumari stretch (NH 44) from Km 188/500 to Km 192/200 (LHS), Km 201/000 to Km 206/500 (LHS), Km 210/000 to Km 210/850 (LHS), Km 211/700 to Km 215/000 (LHS), Km 201/000 to Km 205/300 (RHS), Km 210/000 to Km 216/350 (RHS) and trenchless crossing across the road at Km 190/250, Km 204/000, Km 205/300, Km 211/700 and Km 213/800 in the State of Tamil Nadu which is in conformity with Ministry's guidelines dated 22.11.2016.
- 4) Executive Officer, TWAD Board, Project Division, Valliyoor has furnished an Undertaking to the effect that the applicant will shift the laid water pipeline in future within 90 days if required by NHAI at any time for expansion of the NH at

their own cost without claiming any compensation from NHAI. Further, mentioned that Executive Officer, TWAD Board, Project Division, Valliyoor will also undertake not to damage any other utility, if damaged, will pay the losses either to NHAI or to the concerned agency.

5) As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading.

It is submitted that the proposal for laying of Underground Water Supply Pipelines providing water supply scheme to CWSS to Kalakkadu Municipality and 7 Town Panchayats in Tirunelveli District from Km.188+500 to 192+200 (LHS), Km.201+000 to 206+500 (LHS), Km.210+000 to Km.210+850 (LHS), Km.211+700 to Km.215+000 (LHS) and along the road at Km.201+000 to Km.205+300 (RHS), Km.210+000 to Km.216+350 (RHS) and trenchless crossing across the road at Km.190+250, Km.204+000, Km.205+300, Km.211+700 and Km.213+800 of NH-44 in Madurai Kanyakumari Section has been preferred by the Executive Engineer, TWAD Board, Project Division, Valliyoor.

- 2. The proposal has been scrutinized in the light of Ministry Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and submit the following for kind approval.
 - i. The details of pipeline along the stretch of the project alignment is as follows:

- ii. A plan showing the above mentioned NH stretch with the proposed Pipeline location, cross section of Pipeline Trench have been appended in the proposal.
- iii. The crossing of Water Supply Pipeline has been proposed to lay by HDD (Trenchless) method only.
- iv. It is also stated that there is no alternate route available for laying the water supply pipeline other than the proposed route.
- v. TWAD Board has submitted an agreement in the prescribed format to be executed in case the approval is accorded.
- 3. In this regard, the proposal has been examined by IE and the IE vide ref. 4th cited, stated that the proposed pipe laying works there is possibility of damages to the existing assets of NHAI at various points and requested to the TWAD Board to offset the deficiencies to compensate the consequential damages to the structure belonging to NHAI. The Predicted damages as follows;

- 4. In this connection, the TWAD Board, Project Division, Valliyoor is advised to remittance of road damages to NHAI vide ref. 2nd cited.
- 5. The TWAD Board, Project Division, Valliyoor stated that another water supply scheme belonging to TWAD Board is being implemented by Urban Division, TWAD Board, Tirunelveli namely CWSS to 831 habitations in Tirunelveli District and pipelines are also to be laid by Urban Division, Tirunelveli in the same locations predicted for damages.
- 6. In this regard, it is informed that approval of Competent Authority has been accorded vide RO, Madurai Ir. no. 478. dt. 01.05.2024 for laying of water pipe line along NH 44 Madurai Kanyakumari from Km 202+600 to 209+050, Km 207+650 to 232+350,Km 223+540 to 223+630, Km 229+600 to 229/670, and Km 231+270 to 231/700 and Trenchless crossing (HDD) @ Km. 208+770, 223+630, 229+600, 232+350. However, it was observed that certain damages in the road property has been caused by TWAD Board due to laying of above pipeline in deviation to the approved proposal.
- 7. Accordingly, the Predicted asset damaging estimate on laying of water pipe line by TWAD Board, Tirunelveli from Km. 202+600 to Km.208+800 (RHS) & Km. 208+770 to Km.232+350 (LHS) has been prepared by the Independent Engineer and the abstract of the same is furnished below:

- 8. Vide this office letter no. 2345 dt. 09.11.2024, it was requested the TWAD Board (Urban Division, Tirunelveli) to deposit the above amount to NHAI towards restoration charges for the predictive damages to NHAI properties, to continue the subject pipeline laying work. In response to this, the TWAD Board vide letter dated 20.11.2024 has also accepted to pay the damages and same is yet to be paid by TWAD Board.
- 8. Now, the TWAD Board (Project Division, Valliyoor) has informed that the laying pipeline proposed in this instant proposal also to be laid in the same location and they proposed to execute both the work in same time to avoid damages as recommended by the IE.
- 9. The license fee is calculated in line with the MoRTH circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 for amount of Rs. 1,00,000/- and the same will be deposited by the applicant on approval of the Competent Authority.
- 10. The amount of Performance Bank Guarantee has been calculated in line with the MoRTH policy guidelines dt. 22.11.2016 which is enclosed along with the proposal as detailed below:

11. In view of above, considering the importance of the proposal, since the proposal is essentially required for supply of drinking water, the proposal is hereby recommended for approval of the Competent Authority on the following condition:

- As per MoRTH letter No.RW/NH-33044/29/2015/S&R(R)dated 22.11.2016 wherein "the minimum depth of top of sub grade to casing/conduit pipe should be 1.20m". hence all water pipe line along the National Highway should be laid below 1.2m(minimum) from top of the sub grade.
- The proposed underground water pipeline should be laid at the extreme edge of ROW.
- Hence, the proposal is hereby recommended for approval of the Competent 12. After the subsequent joint inspections along with NHAI officials, it was requested to enunciate the ways and means to be formulated to offset the deficiencies and compensate for the consequential damages to the structures belonging to NHAI vide ref 2nd cited along with the predicted locations of damage.

In this connection, it is hereby informed that another water supply scheme belonging to TWAD board is being implemented by Urban Division, TWAD board, Tirunelveli namely CWSS to 831 habitations in Tirunelveli District and pipelines are also to be laid by Urban division, Tirunelveli in the same locations predicted for damages and the Executive Engineer, TWAD Board, Urban Division, Tirunelveli has received your demand for restoration of mentioned locations and necessary steps are being taken for remitting the charges to NHAI.

In this juncture, I request that after the remittance of road restoration charges to NHAI by the Executive Engineer, TWAD Board, Urban Division, Tirunelveli, the Project Division, Valliyoor may also be permitted to lay the pipeline in the damage predicted locations (810 meters) along with Urban Division, Tirunelveli. For the remaining 14010 meters, the pipeline laying shall be permitted after getting necessary approval from the competent authority

With reference to the above subject and vide reference 2nd cited, the Executive Engineer, TWAD board, Project Division, Valliyoor has requested issuance of NOC for laying of water pipe line (14010mts) works except 810m predicated damaged locations.

In this regard vide reference 3rd cited, PIU, Nagercoil has asked the Independent Engineer to submit the compliance report on the request of applicant.

In this regard, the Independent Engineer has inspected the site at the said locations and our observations are as follows.

Vide TWAD letter no. 0909/F.Kalakkadu CWSS/NHAI/JDO/2024, dated: 09.09.2024, the TWAD board has submitted the revised proposal for laying of water pipe line works. In this regard, PIU, Nagercoil vide letter no. NHAI/PIU/NGL/TWAD/2024/2044, dated: 02.10.2024 has asked the Independent Engineer to verify the proposal and recommend for approval. Subsequently the Independent Engineer along with TWAD board representative and Concessionaire representative has made a joint inspection on 09.10.2024 and some predicated damages are identified and communicated by Independent Engineer vide letter no. MSV-Sri Infotech/114/NHAI/IE/Kayathar-Kanyakumari/NH-44/2024/280, dated: 17.10.2024 in which it was mentioned that TWAD board may have to pay an amount of Rs. 1,49,04,654/- (including GST) to NHAI/ Concessionaire for predicated damages in NHAI assets.

In this regard, TWAD board, Tirunelveli Division, water pipe line works are in progress from Km. 202+600 to 232+400 and also Independent Engineer has requested the TWAD representatives of Valliyoor division which is to proposed the water pipe line in same direction in TWAD Board, Tirunelveli Division and reduction of the predicated NHAI damages.

(i) TWAD board Tirunelveli has to remit the amount of Rs.1,98,93,038/- for the predicated damages for the pipeline laying.

- The Superintending Engineer, TWAD, Tirunelveli shall submit an undertaking stating that both the pipeline works shall be completed by them in a single excavation to avoid repeated damages to NHAI assets, for which no additional damages shall happen than the predicated damages listed by Independent Engineer (Enclosed letter no: MSV-Sri Infotech/114/NHAI/IE/Kayathar-Kanyakumari/NH-44/2024/280, dated: 17.10.2024) and if any additional damages occur, NHAI may fort for the Bank Guarantee.
- TWAD Valliyoor shall obtain approval from Competent Authority and after obtainance, both the pipes may be laid in (iii) a single go subject to conditions and specifications.

As both the pipelines are to be laid in the same alignment, it is advisable to lay both the pipes at a single time to avoid repeated damages to NHAI assets.

The same may please be apprised to the applicant.
