SUB: Six-laning of Ahmedabad-Vadodara section of NH-8 (Km 6+400 to Km 108+700)(Length 102+300Km) in the state of Gujarat & Improvement of Ahmedabad-Vadodara Expressway from Km 0+000 to Km 93+302 in the state of Gujarat (Length 93.302 Km.) under NHDP Phase V on DBFOT Toll Basis.

- Proposal for ROW permission for laying 450 mm Dia Water Pipeline (with casing pipe of 900mm) across NH-48 at Km 102+575, near Village-Ranoli, & District Vadodara on Ahmedabad - Vadodara section of NH-8 in the state of Gujarat.


