Vide letter (1) under reference, M/s Town Municipal Bidadi, Bidadi has submitted the proposal as per MORT&H guidelines for issue of Permission to lay various diameter and HDPE drinking water supply pipeline along and across National Highway -275 on Bengaluru to Mysuru section and proposed Bidadi Bypass near Bidadi Town for providing water supply scheme to Bidadi Town & 9 enroute villages with Manchanabele Reservoir as source in Six laning of Bengaluru Nidaghatta Section of NH-275 from Km.18.000 to km.74.200 in the state of Karnataka.

As per the Circular No.RW/NH-33044/29/2015/S&R (R), Dt.22-11-2016 of the Ministry of Road Transport & Highways (MORT&H), New Delhi, the application shall be put out in public domain for 30 days seeking claims and objections on the grounds of public inconvenience, safety and general public interest.

As per Para-4 of Ministry Circular 2nd under reference, the Highway Administration shall be put out in the Public Domain for 30-Days for seeking claims and objections (On grounds of Public Inconvenience, safety and general public interest).
