Invitation of Public Comments

Sub: NHAI, RO, Chennai - PIU, Krishnagiri - M/s. Telesonic Networks Limited, Chennai requested for permission to lay underground Optical Fiber Cable (OFC) along the road from km.91+500 to km.92+900 (RHS) and one number of Road crossing at km.92+880 on Hosur - Krishnagiri section of NH-44(Old NH-7) - Reg.

The proposal is regarding laying of Optical Fibre cable along the road from km.91+500 to km.92+900 (RHS) and one number of Road crossing at km.92+880 on Hosur – Krishnagiri section of NH-44(Old NH-7) by M/s. Telesonic Networks Limited, Chennai and submitted to this office by the PD, NHAI, Krishnagiri vide letters No. NHAI/11013/OFC/2021/PIU-K'giri/622 dated 14.06.2021.

- 2. The available width of ROW is 53.375 m on RHS and 39.525 m on LHS. It is proposed to lay the OFC at edge of RoW i.e. at extreme distance from centre line of the main carriageway.
- 3. M/s. Telesonic Networks Limited, Chennai has proposed to lay OFC along the road by open trench method and across the road and intersection locations by HDD method. It is proposed to lay 20mm dia OFC Cable (2 nos.) along the road by open trench method encased in 40mm dia PLB pipe duly keeping the top of the casing at 1.65 m below the top of sub grade level. Further, the applicant has proposed to lay the 20mm OFC cable (2 nos) across NH by HDD method, encased in 40mm PLB pipe, which in turn encased in 150mm RCC pipe duly keeping the top of the casing pipe at a depth of 1.65m below the top of sub grade level.
- 4. M/s. Telesonic Networks Limited, Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished undertaking that they will adopt HDD method wherever, the available width of ROW is less than 15m.
- 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M/s. Telesonic Networks Limited, Chennai will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
