- In above cited subject, it is intimated that Bhiwani-Hansi-Barwala-Tohana (Pb/HR Border) section of NH 148B was entrusted to this office to NHAI vide SO. No. 1457 (E) dated 09.05.2017 same was transferred to this PIU vide NHAI HQ letter no. NHAI/Tech/Haryana/Misc/2017/104229 dated 11.08.2017.
- 2. With respect to Para no2 of checklist, it is submitted that at present DPR for upgradation of this stretch has been kept on hold as alignment approved by your office dated 25.05.2018 was declined by NHAI HQ on 09.04.2019. This portion of Bhiwani to Hansi of Nh-148B has been included in High-2 priority in Bharat Malascheme.
- 3. In this regard, it is intimated that the proposal was sent to RO, MoRTH, Chandigarh vide this office letter no. 1153 dated 03.06.2019 (copy enclosed) for approval. RO, Chandigarh has raised some observation vide their letter under reference (i).
- 4. Executive Engineer, Bhiwani vide letter under reference (ii) has submitted the compliance of the observations and requested to issue access permission. The same was sent to I.E M/s CEG, Hisar for comments. Independent Engineer M/s CEG, Hisar vide letter no. 1873 dated 01.11.2019 has raised certain observations which were further conveyed to applicant.


