SUB: Six-laning of Ahmedabad to Vadodara section of NH-8 (Km 6+400 to Km 108+700)(Length 102+300 Km) in the state of Gujarat & Improvement of Ahmedabad-Vadodara Expressway from Km 0+000 to Km 93+302 in the state of Gujarat (Length 93.302 Km.) under NHDP Phase-V on DBFOT Toll Basis.


