Invitation of Public Comments

Sub: NHAI, RO Chennai – PIU, Krishnagiri– Permission proposal for laying of pipeline along the road from km.19/725 to km.19/975(RHS) and km.22/400 to km.23/390 (RHS) and Road Crossing at km.19/725 and km.23/390 on Krishnagiri - Walajahpet section of NH-48 (Old NH-46) from Executive Engineer, TWAD Board, Krishnagiri – Approval - Reg.

The proposal is regarding permission for laying of Water Pipeline on Krishnagiri - Walajahpetsection of NH-48 in the limits of National Highways by Executive Engineer, TWAD Board, Krishnagiri was submitted to this office by the PD, PIU, Krishnagiri vide Letter No. NHAI/11013/TWAD/2019/PIU-K'giri/ 703 dated. 24.06.2020 in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment now proposed by Executive Engineer, TWAD Board, Krishnagirifor laying of water pipe line along and across crossing Krishnagiri-Walajahpet section of NH-48 (Old NH-46) as detailed under:

3. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.

4. Executive Engineer, TWAD Board, Krishnagiri has furnished an undertaking to the effect that he will shift the pipeline if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost & risk without claiming any cost from NHAI. Further, he has furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of pipeline will not have any deterious effect on any of the bridge components and road way safety for traffic.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, Krishnagiri will be made available for public comments/objections and the comments will be invited within 30 days from the day of uploading.
