

- 2. The alignment proposed by that M/s Jio Digital Fiber Pvt. Ltd. along NH-361 from Ch. 410/000 to Ch. 477/000 for the total length 67 km. In the state of Maharashtra is as follows:
 - To lay Optical Fiber Cable (OFC) from Ch. 410/000 to Ch. 477/000 (LHS) along the NH-361 in utility duct.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
