Div. Controller, M/s Maharashtra State Road Transport Corporation, Nashik vide letter cited above has submitted Proposal for 01 no. of Crossing of Underground 33/11 KV Electrical Line across (Pimpalgaon-Nashik-Gonde Section) of NH-3 for approval of the Competent Authority, Highway Administration.
