- Proposal seeking ROW permission for laying of 132KV D/C 1CX 800 Sqmm (3+3) Total 6 nos. of U/G Electric Power Cable line from 220KV Karjan S/s to Switchyard of M/s. NHRCL for their Thikariya Mubarak Traction Substation along NH-48 from (i) Km 153+600 to Km 151+760, (ii) from Km 151+860 to Km 151+760 and (iii) Across NH-48 at Km 151+860, near Village-Miyagam Karjan, Taluka-Karjan, District-Vadodara in the state of Gujarat.
