INVITATION OF PUBLIC COMMENTS

Sub: Permission for laying of 90 mm dia to 315 mm dia water carrying pipe from chainage 355+400 to 360+200 along both the sides of NH-12 (Old NH-34) by open trenching and refilling method and a crossing at chainage between 357+800 and 357+900 by HDD method under MAHTL Piped Water Supply Scheme at GAZOLE Blok under Malda Division, PHE Dte in the state of West Bengal.

The Project Director, PIU – Malda, NHA vide letter no. 620116/1/2024-25/AP-PHE(MLD)/09/556 dated 04.09.2024 has submitted the subject proposal of PHED Malda Division for granting license for use of National Highway land.

2. The proposal for laying 90mm dia to 315mm dia water pipeline along and across NH-12 (Old NH-34) as under:
