Sub: 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 from Km.652.000 (New Km.653.225) to Km.729.000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis-Permission for laying of 11 KV 3C x 185 sqmm SLPE underground HT express feeder line from Dongargaon to Jamtha (from km 17.400 to km 18.500 LHS) on Nagpur-Hyderabad section of NH-44-Approval-Reg.
