Vide letter cited 1st above, the Executive Engineer, RDW&S Division, Bangalore Urban, vide letter under reference, has requested permission for laying of the water supply pipe line 1) from Km 23.800 to km 24.600 RHS of 75mm dia. and Km24.100 to Km 24.410 LHS of 75mm dia. by open trench method and crossing at 24.410 by IIDD method, 2) from Km 22.090to Km 22.305 (LHS) of 273 mm dia. by open trench method & crossing at Km 22.305 by HDD method along NH-275 near Kaniminike village, Bengaluru south taluk & Bengaluru urban district & Karnataka state.

As per the Circular No.RW/NH-33044/29/2015/S&R (R), Dt.22-11-2016 of the Ministry of Road Transport & Highways (MORT&H), New Delhi, the application shall be put out in public domain for 30 days seeking claims and objections on the grounds of public inconvenience, safety and general public interest.

As per Para-4 of Ministry Circular 2^{nd} cited, the Highway Administration shall be put out in the Public Domain for 30-Days for seeking claims and objections (On grounds of Public Inconvenience, safety and general public interest).

In view of the above, the comments/objections of affected is hereby invited with reference to Ministry Circular 2^{nd} cited, for the above mentioned proposal.
