It is to inform all concern that M/s MIDC, Div. No.-II Nagpur vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that MIDC, Div. No.-II Nagpur along on Saoner-Dhapewada-Kalmeshwar-Gondkhairi section of NH-547E in the State of Maharashtra is as follows:

- Laying of pipeline along Highway from km 25.300 to km 26.900 through HDD method.
