INVITATION OF PUBLIC COMMENTS

Sub: NHAI-PIU-NSK- Six Laning of Pimpalgaon-Nashik-Gonde Section of NH-03 from Km 380/00 to 440/00 in the State of Maharashtra - Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL) Proposal for Laying of Overhead Electrical 11 KV HT Line on RSJ Pole from Km. 397.500 to Km. 398.000 (RHS) on NH-3.

Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL), Rural Division, Nashik vide letter cited above has submitted proposal for Laying of Overhead Electrical 11 KV HT Line on RSJ Pole along NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Laying of Overhead Electrical 11 KV HT Line is proposed from Km. 397.500 to Km. 398.000 (RHS) along NH-3 (Pimpalgaon-Nashik-Gonde Section) within NHAI-ROW (Total Length - 0.5 Km).

As per Para-4 of Ministry of Road Transport & Highways (MoRTH) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
