Sub: NHAI, PIU, Puducherry - (N/08019/02002/TN) - Four laning of Puducherry (Km.29/000) to Poondiyankuppam (Km.67/000) Section of NH-45A (New NH-32) on HAM under Bharatmala Pariyojana in the state of Tamil Nadu and UT Puducherry under NHDP Phase - Laying of proposed 8" (219mm) Carbon Steel and 125mm MDPE Gas Pipeline along the NH-45A from Existing Km.62/934 to Km.64/096 (LHS) for a total length of 1162m to develop City Gas Distribution Network in Cuddalore - Invitation of Public Comments - Reg.

1. The subject proposal is requesting permission for laying proposed 8 Dia (219 mm) carbon steel & 125 mm MDPE Gas Pipeline along the existing road from Km.62/934 to Km.64/096 (LHS) for a total length of 1162m in the project stretch of Puducherry to Poondiyankuppam Section of NH-45A (New NH-32) in the State of Tamil Nadu and UT of Puducherry by M/s. Adani Total Gas Limited in accordance with Ministry's latest guidelines Dt.22.11.2016.

2. M/s. Adani Total Gas Limited has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Adani Total Gas Limited will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
