By way of this public notice, it is to inform all concern that M/s Adani Total Gas Ltd. has submitted a proposal for Permission for laying ATGL 200mm NB Carban Steel Gas pipeline across the NH-152D (Ch. 141.970 to Ch. 141.050) & 141+050 & 141+970 in the State of Haryana. The said line has its crossing & along with Trans Haryana Greenfield project of NH-152D (Ismailabad-Narnaul) under NHAI RO-Delhi, at its Km. Ch. 141.970 to Ch. 141.050 (Along) & Km 141+050 & Km 141+970 (Crossing) in PKG-6.
