**INVITATION OF PUBLIC COMMENTS**

Sub:- NHAI, RO-Kerala - Existing 2 Lane NH-966 from Kozhikode to Palakkad (Km.15+656 to Km.140+960) in the State of Kerala-Laying of Natural Gas Pipeline from Kottappuram to Valluvampuram (Km.23+800 to Km.38+300 RHS and crossing at Km.29+300 & Km.38+300) of NH-966 by M/s IOAGPL-Reg.

The proposal is regarding permission sought by M/s IndianOil Adani Gas Private Ltd. (IOAGPL) for laying of underground Natural Gas pipeline from Km.23+800 to Km.38+300(RHS) and crossing at Km.29+300 & Km.38+300 in the subject project stretch in the State of Kerala.

2. M/s IOAGPL has furnished undertaking to shift the gas pipeline at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken for payment of rent/fee and to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, M/s IOAGPL has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s IOAGPL has also undertaken to manage traffic movement during the execution of the work.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s IOAGPL will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
