Invitation of public comments

**Subject:-** Permission proposal for laying sewage pipeline along the road from Km 16/250 to Km 16/400(LHS) and across the road at Km 16/250 of NH-648(Sharjapur-Bagalur-Hosur Road) in the state of Tamil Nadu for a total length 343m (2 Nos of pipeline along the road 300m & 2 crossing total length 43m) by the Executive Engineer, TWAD Board, Project Division, Krishnagiri -Reg.

The proposal is regarding requesting permission for laying sewage pipeline along the road from Km 16/250 to Km 16/400(LHS) and across the road at Km 16/250 of NH-648(Sharjapur-Bagalur-Hosur Road) in the state of Tamil Nadu for a total length 343m (2 Nos of pipeline along the road 300m & 2 crossing total length 43m) by the Executive Engineer, TWAD Board, Project Division, Krishnagiri resubmitted to this office by the SE (NH), Salem vide letter No.3617/2024/DO/NH dated 04.07.2025(received on 09.07.2025). The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying sewage pipe line is 22.00m. The carriageway width of stretch from Km 16/250 to Km 16/400 of NH 648 is 20.20m. The Executive Engineer, TWAD, Project division, Krishnagiri has proposed to lay the underground Public Utility at edge of the ROW for a length of 300m(2 Nos pipelines and each of 150m) by adopting open trench method along the National Highway and crosses the National Highway at Km 16/250.

3. The Executive Engineer, TWAD, Project division, Krishnagiri has furnished an undertaking to the effect that they will remove the laid Public Utility sewage pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD, Project division, Krishnagiri will also restore the ROW surfaces to its original condition soon after removal of the

Public utility sewage pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
