INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Four laning of Kazhakuttam to Mukkola section (Km.0+000 to Km.26+500) of NH-66 in the State of Kerala under NHDP Phase-III on EPC mode-Laying of 33 KV 3Cx300 Sqmm UG Cable in underground manner by HDD method from Km.26+393 to Km.26+509(RHS) and crossing at Km.26+509 of NH-66 (Thiruvananthapuram Bypass)-Reg.

The proposal is regarding permission sought by M/s Adani Vizhinjam Port Pvt.Ltd., Thiruvananthapuram for laying 33 KV 3Cx300 Sqmm UG Cable in underground manner by HDD method from Km.26+393 to Km.26+509(RHS) and crossing at Km.26+509 in the subject project location in the State of Kerala.

- 2. M/s Adani Vizhinjam Port Pvt.Ltd., Thiruvananthapuram has furnished undertaking to bear all expenditure, if any, incurred by NHAI for repairing any damage caused to NH by laying, maintenance or shifting of UG cable. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, M/s Adani Vizhinjam Port Pvt.Ltd., Thiruvananthapuram has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. M/s Adani Vizhinjam Port Pvt.Ltd., Thiruvananthapuram has also undertaken to manage traffic movement during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Adani Vizhinjam Port Pvt.Ltd., Thiruvananthapuram will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
