Ena Section of Vadodara-Mumbai Expressway Bharatmala Project) in the State of Gujarat under NHDP Phase-VI on HAM mode [Phase IA/IB - (Package VI, ENA-KIM)].:- Permission for Overhead crossing at Ch. 215+703 of VME-Package-VI, for the Construction of 765 KV D/C Vataman-Navsari Transmission Line associated with "Transmission System Network for Evacuation of additional 7 GW RE Power from Khavda RE park under Phase-III Part-B Vill. The PD, NHAI, PIU-Surat vide letter u/ref.(1) has recommended the instant proposal of DGM, Navsari, M/s Powergrid Vataman Transmission Ltd. (PGCIL) vide their office letter u/ref.(3), as recommended by Supervision Consultant vide their office letter u/ref. (2), seeking Permission required for overhead crossing of VME P-6 at Km. 215+703 near village Ena, Taluka-Palsana, District-Surat for the construction of 765 KV D/C Vataman-Navsari Transmission Line associated with "Transmission System Network for Evacuation of additional 7 GW RE Power from Khavda RE park under Phase-III Part-B through tariff based Competitive bidding (TBCB) Route.
