Sub.: Four laning of Gujarat/Maharashtra Border - Surat - Hazira Port Section of NH-6 (approx. length 131.500 km) in the State of Gujarat under NHDP Phase-III-Proposal seeking ROW Permission for Drinking water supply Pipe line of crossing (i) km 50.200 at village Kanav (ii) km 54.00 at village Ena (iii) km 46.300 at village Itadva and Parallel line (iv) km 44.050 to km 48.200 on LHS (v) km 53.400 to km 54.00 on RHS and (vi) km 56.700 to km 60.300 on LHS of NH-53 Proposed 300 mm Dia PVC pipe & 400 mm Dia RCC pipe to establish water supply scheme for different Villages of Surat-District.
