Invitation of public comments

Subject:- Permission proposal for laying of UG water pipe line along the road at Km.18/900 to 20/960 (LHS), Km.23/110 to 25/860 (RHS) and 25/860 to 28/500 (LHS), Km.28/500 to 29/100 (RHS) and across the road at Km.20/475, Km.20/960, Km. 23/110, Km.25/860 & Km.28/500 of NH 383 Ext (Kottampatti to Thiruppathur) for providing CWSS to 8 town panchayats, 2452 Rural Habitation and Bulk provision to 3 Municipalities in Sivagangai district in the state of Tamil Nadu -Regarding.

The proposal is regarding request for permission proposal for laying of UG water pipe line along the road at Km.18/900 to 20/960 (LHS), Km.23/110 to 25/860 (RHS) and 25/860 to 28/500 (LHS), Km.28/500 to 29/100 (RHS) and across the road at Km.20/475, Km.20/960, Km. 23/110, Km.25/860 & Km.28/500 of NH 383 Ext (Kottampatti to Thiruppathur) for providing CWSS to 8 town panchayats, 2452 Rural Habitation and Bulk provision to 3 Municipalities in Sivagangai district in the state of Tamil Nadu by the Executive Engineer, TWAD Board, Project Division, Karaikudi submitted to this office by the SE (NH), Madurai vide letter No.1460 /2022/DO/ dated 26.06.2023. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying Water pipe line is varying from 12.5m to 39.00m. The carriageway width of stretch from Km.18/900 to 20/960 (LHS), Km.23/110 to 25/860 (RHS) and 25/860 to 28/500 (LHS), Km.28/500 to 29/100 (RHS) and of NH 383 Ext (Kottampatti to Thiruppathur) is varies from 10.00m to 10.20m. The Executive Engineer, TWAD Board, Project Division, Karaikudi has proposed to lay the underground Public Utility at edge of the ROW for a length of 8050m by adopting open trench method along the National Highway and HDD method across at cross the road at Km.20/475, Km.20/960, Km. 23/110, Km.25/860 & Km.28/500 the National Highway.

3. The Executive Engineer, TWAD Board, Project Division, Karaikudi has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, Project Division, Karaikudi will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
