Sir,

With reference to the subject cited above, it is to state that the above proposal of "Permission to lay Water Supply pipe line by RWS&S Division, Sonapur" was submitted to your good office vide this office letter u/r-(iv) along with necessary supporting documents, duly signed draft agreement and duly signed undertaking by Superintending Engineer, RWS&S Division, Sonapur as per Ministry's Circular dated 22.11.2016. The agreement and undertaking copy is again enclosed for your kind reference.

As per point of 21 of draft agreement "*The licensee shall shift the utility service within 90 days (or as specified by the respective Authority) from the date of issue of the notice by the concerned Authority to shift/relocate the utility services, in case it is so required for the purpose of improvement/widening of the road/route/highway or construction of flyover/bridge and restore the road/land to its original condition at his own cost and risk.*"

As per point of 5.4 of undertaking "*We do hereby undertake to shifting of water supply pipe line as and when required by MoRTH at Our own cost.*"

As per point of 5.5 of undertaking "*We do hereby undertake to shift the pipe lines for future 6 laning/ widening of NH at our own cost subjected to commencement of the 6 laning/ widening work should be within date of due right approval from the NH Division, Bolangir*"

As per point 2(a) of your good office letter u/r-(iii) "*The engagement of consultancy services for preparation of 4-laning DPR of the subject stretch has been agreed by the Competent Authority in the meeting held on date 24.04.2025 and bids shall be invited after approval of Annual Plan 2025-26. Hence, the proposal needs to be examined keeping in view the future widening of that section.*"

As the ROW available in above stretch of NH-57 from Km 15/580 to Km 44/000 is not sufficient for 4-laning so land acquisition will be made by NH department for proposed widening. Hence, the proposed pipe line in the instant case will be required shifting for proposed 4laning by our department in annual plan 2025-26.

The point no 5.5 of previous undertaking submitted by Superintending Engineer, RWS&S Division, Sonapur is not clear cut but conditional. Therefore, a fresh undertaking in this regard was requested from Superintending Engineer, RWS&S Division, Sonapur vide this office u/r-(ii) which says *"The Water Supply pipe line proposed to be laid along NH-57 from Km21/300 to Km40/230(LHS), from Km15/580 to Km40/230(RHS), from Km43/550 to 44/000(RHS) & Across the Chainage Km15/580, Km21/300, Km28/100, Km30/500, Km33/600, Km34/100, Km38/100, Km39/900, Km40/230 & Km44/000 under RWSS Division Sonapur will be shifted by RWS&S Division, Sonapur for proposed widening to 4lane of above stretch by NH Division Bolangir. Complete shifting cost will be borne by RWS&S Division, Sonapur"* for onward submission to the Ministry for its kind consideration

Subsequently, the Superintending Engineer, RWS&S Division, Sonapur vide his letter u/r-(i) has stated that *"A convergence meeting was held on date 25.08.2025 at Bhubaneswar, chaired by the commissioner-cum-Secretary, PR&DW Department and attended by officials from MoRT&H, RWS&S and NH. During the meeting it was decided that no under taking is required towards shifting cos for laying the pipeline and necessary documents may be processed accordingly."*

Therefore, it is requested that necessary instruction may kindly be given in this regard as future shifting of proposed pipe line won't be borne by RWSS.

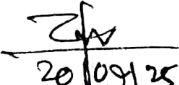

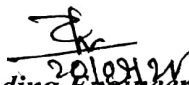

With reference to the subject cited above and the letters mentioned in the reference, M/s Megha Engineering & Infrastructure Limited, Hyderabad, was awarded the above-mentioned work as per the reference letters (ii) & (iii). This work involves providing drinking water supply to 127 villages in Sonepur Block and 138 villages in Tarava Block under Subarnapur District, including 5 years of Operation & Maintenance (O&M). The Mega Pipe Water Supply project between these two blocks is progressing rapidly, and it is expected to be completed by the end of this year, 2025.

During the execution of the project, certain pipelines are planned to be laid along and across NH-57. The details of the locations where this will occur are as follows:

(i) Along the Road:

- Ch. 21/300 Km to 40/230 Km (LHS)
- Ch. 15/580 Km to 40/230 Km (RHS)
- Ch. 43/550 Km to 44/000 Km (RHS)

(ii) Across the Road:

- Ch. 15/580 Km, Ch. 21/300 Km, Ch. 28/100 Km, Ch. 30/500 Km, Ch. 33/600 Km, Ch. 34/100 Km, Ch. 38/100 Km, Ch. 39/900 Km, Ch. 40/230 Km & Ch. 44/000 Km.

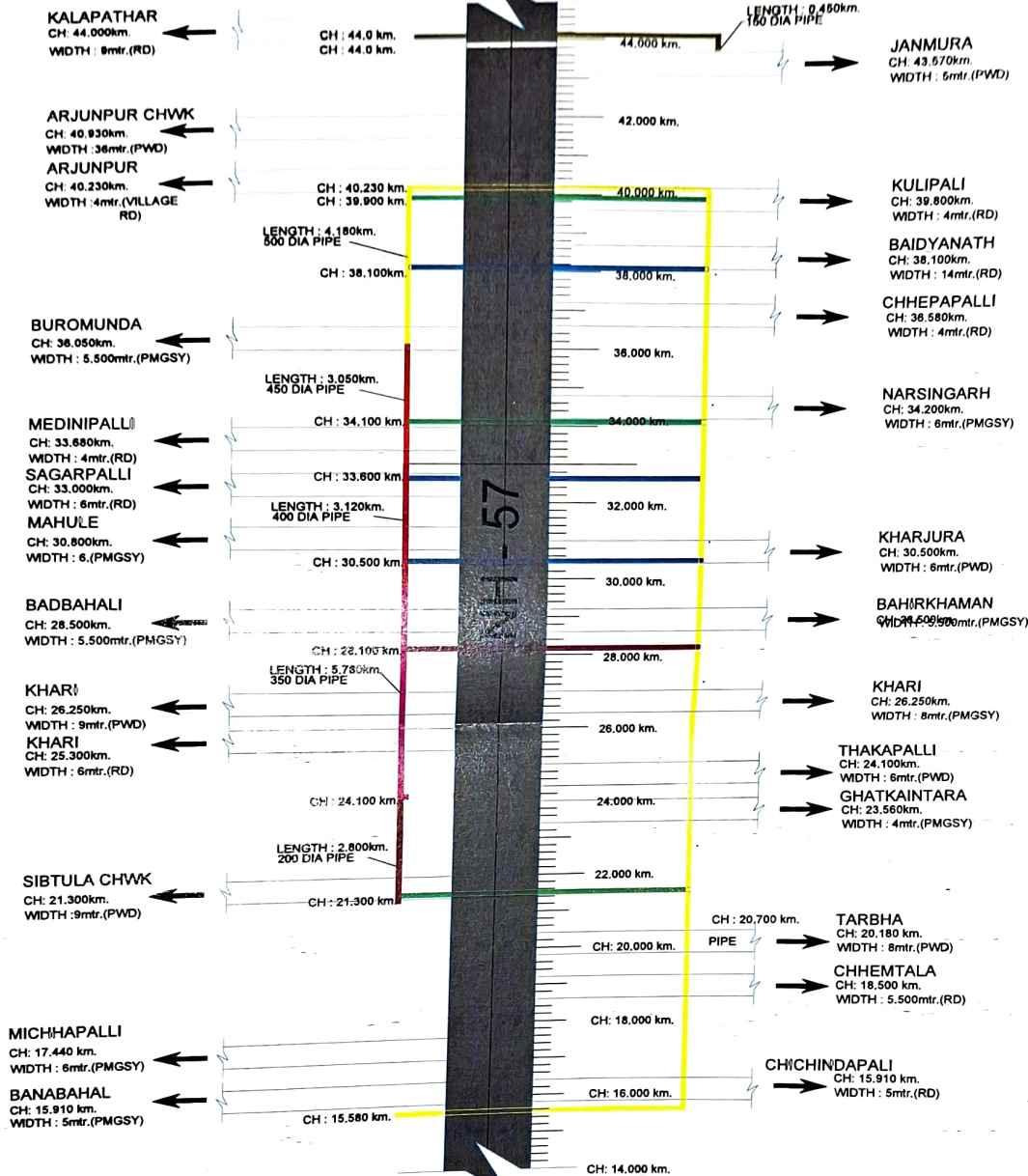
