Sub : Regarding compliance of observation for granting NOC for Water Supply pipe laying in NH-80- for Rajmahal Urban Water Supply Scheme (non- shoulder portion).

Your kind attention is invited to letter u/r (i) received from JUIDCO regarding grant of permission for laying of water pipeline along NH-80 for Rajmahal Urban Water Supply Scheme (non- shoulder portion).

2. The application received from JUIDCO was submitted to your good office vide letter no. NHAI/PD/PIU/SBG/NH-80/JUIDCO/134 dt. 04.05.2023. However, RO, Ranchi, raised some observations vide letter u/r (ii), and the same was communicated to JUIDCO vide letter u/r (iii) & (iv).

3. The compliance of the same has been received from the office of JUIDCO vide letter u/r (iv). The same has been examined and are as below:

Sl. No.	Observations	Compliances
1.	It is requested to submit the utility plan superimposed on the plan & profile of existing carriageway and available ROW.	The same is submitted in A-2 color drawing. (The sewer line, proposed water pipe line is superimposed on the alignment.) It is further submitted that the available ROW is varying between 3.5-5.5m.
2	It is requested to conduct joint site survey along with officials of M/s JUIDCO to check the feasibility of pipe laying at the edge of ROW and also may find any alternate route for laying of water pipeline.	It is to say that Rajmahal town is habitated linearly on both the side of National Highway only and there is no alternate route for pipe laying as distribution has to be done on houses located besides National Highway. The same has also been discussed during meeting under the Chairmanship of DC Sahibganj, on 12.08.2023. During meeting, JUIDCO officials submitted that there is no alternate route available considering the location of treatment plant and water tanks.

		<p>DC, Sahibganj instructed NHAI to convey NOC within week to complete the water supply works at the earliest.</p> <p>Further, joint site visit was also conducted and it was found that there is no any alternate route available for laying water pipeline.</p>
3	<p>It appears that only 3.5-5.5M ROW is available in which existing road is there. The laying of utility seems to be affecting main carriage way and is not in accordance to the MORTH Policy Guidelines dated 22.11.2016 & will have hazardous effect on day today movement of traffic. therefore, thorough investigation shall be done before recommending such proposal.</p>	<p>As detailed above, for supplying drinking water to the public, water pipeline has to be laid on/ beside NH only.</p> <p>Further, it is agreed that the said proposal is not in conformity of MoRTH policy Guideline dated 22.11.2016. However, in view of importance of drinking water supply project, references from public representative and directions from DC, Sahibganj, provision of laying of pipeline by providing 1 to 1.25m box designed to carry traffic on top as recommended earlier may be considered. Traffic management plan for safe day to day traffic movement has been submitted by JUIDCO as below:-</p> <ul style="list-style-type: none"> • Placement of 3-4 sign Boards for information and guidance. • Flagmen/Marshal will be available for traffic management. • Wherever required safety Danger Tapes will be placed. • All the works will be carried out under the guidance of NHAI, any necessary changes will be made as suggested by NHAI.

4. In view of the above, the proposal of JUIDCO regarding grant of permission for laying of water pipeline along NH-80 for Rajmahal Urban Supply scheme non- shoulder portion in Sahibganj District, Jharkhand is hereby recommended for your kind approval please.
