This is in continuation of above referred letter S.No.(I to IV) between DJB and NHAI and subsequently reference letter at S.No.V was received in BYPL KCC office on dated 25.05.2025 from DJB regarding submission of proposed HT feeder route drawing as per MoRTH circular no. RW/NH-330044/29/2015/S&R(R) dated 22.11.2016 along with duly signed drawing by the competent authority for P-3 ranney well DJB electric connection.

It is to be submitted that proposed 11 KV HT cable to be laid through NHAI trench along the NH-24 once approval is received from NHAI ,having a total length of circuit is 2* 1346 mtr (as per GIS map attached) out of which approx. 2*800 mtr (1.6 KM) circuit of size 3x300 SQMM having a diameter of 80 MM will be laid through NHAI existing utility trench. GIS mapped proposed HT cable route signed drawing has been enclosed herewith for your kind reference PI.

So, It is requested to provide a cable laying permission along with way leave/rental charges demand note as mentioned in NHAI circular dated 22.11.2016 for cable laying through utility trench .Pl.arrange the same on priority basis as DJB ranney well connection will be used in larger public Interest for meet the water shortage issue in near by locality.

Also share bank account detail in which amount have to be deposited once demand received to us. It is requested that If any additional documentation required please feel free to contact us.
