Sub: NHAI-PIU, Dindigul - Two Laning with Paved Shoulders of Dindigul-Theni Section from Km 2/750 to Km 73/400 of NH-45E and Theni-Kumili Section from Km 215/000 to Km 273/600 of NH 220 in the State of Tamil Nadu - Laying of API 5L GR X 52, 12"X6.4 mm thickness of CS Underground Gas Pipeline along the road from Km 02/750 to Km 14/370 (LHS) and Crossing @ Km 02/750 of NH-183 Road (Dindigul - Theni section) for a total length of 11649 m in Tamil Nadu State - Invitation of Public Comments - Reg.

The proposal received from PD, Dindigul vide Lr.No-NHAI/PIU/DGL/11014/DTK/NOC/2023/922 dated 27.04.2023 there by requesting permission for laying gas pipe line along the road from Km 02/750 to Km 14/370 (LHS) and Crossing @ Km 02/750 of NH-183 Road (Dindigul - Theni section) for a total length of 11649 m in the State of TamilNadu proposed by, M/s Megha city gas Distribution Private Ltd, Trichy.

2) The alignment proposed by the, M/s Megha city gas Distribution Private Ltd, Trichy. requesting permission for laying of gas pipeline along the road from Km 02/750 to Km 14/370 (LHS) and Crossing @ Km 02/750 of NH-183 Road (Dindigul - Theni section) for a total length of 11649 m in the State of TamilNadu detailed as under;

3) As mentioned in the PD letter, the ROW is varying from 17 m to 49m. As mentioned in the proposal, the pipe line are to be laid across NH at km.02/750 through HDD method.(Strip plan enclosed for reference)

4) In this instant proposal, as certified by PD, Dindigul the gas pipeline along the road is proposed to be laid at 1.20m from top of the sub grade which is higher than the Ministry stipulation of minimum 0.6m meter below the ground level.

5) Crossing has been proposed by trenchless method (HDD) and the pipe will be laid at depth of 1.20 m top of the sub grade which satisfies the Ministry stipulation of minimum 1.20 meter as per MoRTH guidelines.

6) M/s Megha city gas Distribution Private Ltd, Trichy has furnished an undertaking to the effect that the applicant will remove the laid gas pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost. Further,

mentioned that M/s Megha city gas Distribution Private Ltd, Trichy will also restore the surfaces to its original condition soon after laying of the gas pipelines.

7) Accordingly, as per Policy Guidelines issued by Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and subsequent Amendment dated 17.04.2023. the application is being uploaded on public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
