INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Six laning of Existing Kozhikode Bypass (i.e. Vengalam Jn. to Ramanattukara Jn.) from km 230.400 to km 258.800 (Design Chainage) of NH-66 in the State of Kerala under NHDP Phase-III on Hybrid Annuity Mode -Laying of 3x300 Sqmm 11KV UG Cable for 150m from Km.242+840 to Km.242+990(LHS) by M/s Malaparamba Commercial Complex LLP, Kozhikode-Reg.

The proposal is regarding permission sought by M/s Malaparamba Commercial Complex LLP, Kozhikode for Laying of 3x300 Sqmm 11 KV UG Cable for 150m from Km.242+840 to Km.242+990(LHS) in the subject project stretch in the State of Kerala.

- 2. M/s Malaparamba Commercial Complex LLP, Kozhikode has furnished undertaking to shift the underground Pipeline at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, M/s Malaparamba Commercial Complex LLP, Kozhikode has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. M/s Malaparamba Commercial Complex LLP, Kozhikode has also undertaken to manage traffic movement during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Malaparamba Commercial Complex LLP, Kozhikode will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
