Sub: Four Laning of Hospet - Chitradurga section of NH 13 (New NH-50) from km 299+000 to km.418+750 in the state of Karnataka under National Highways Development Project (NHDP) Phase III on DBFOT (Toll) basis ("Project") - Permission for laying of underground water supply pipeline of Dia 273 mm in utility corridor from Km. 432.600 (Old Ch. 311.600) to Km. 432.675 (Old Ch.313.675) (0.075 kms) on RHS, from Km. 432.675 (Old Ch. 311.675) to Km. 434.650 (Old Km. 313.650) (1.975 Kms) on LHS and 1 No. of crossing at Ch. 432.675(Old Km.311.725) across NH-50 for feeding line for M/s MSPL company from Tungabhadra Reservoir - Reg.

M/s MSPL vide letter cited above, has submitted the proposal for laying of underground water supply pipeline of Dia 273 mm in utility corridor from Km. 432.600 (Old Ch. 311.600) to Km. 432.675 (Old Ch.313.675) (0.075 kms) on RHS, from Km. 432.675 (Old Ch. 311.675) to Km. 434.650 (Old Km. 313.650) (1.975 Kms) on LHS and 1 No. of crossing at Ch. 432.675(Old Km.311.725) across NH-50 for feeding line for M/s MSPL company from Tungabhadra Reservoir for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying of 273 mm dia pipeline along from Km.432+600 (Old Ch. 311.600) to 432+675 (Old Ch.313.675) on RHS, From Km. 432.675 (Old Ch. 311.675) to Km. 434.650 (Old Km. 313.650) on LHS and crossing at Km. 432+725 (Old Km.311.725)of Hospet - Chitradurga section of NH 13 (New NH-50).

3. As per para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016, the Highway Administration shall be put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
