SUB: Six Laning of Ahmedabad to Vadodara section of NH-8 from Km. 6.400 to Km. 108.700 (Length 102.300 Km.) and Improvement of Ahmedabad-Vadodara Expressway from Km. 0.000 to Km. 93.302 in the State of Gujarat (Length 93.302 Kms) under NHDP Phase V on Design, Build, Finance, Operate & transfer (DBFOT) Toll Basis.

- Proposal for ROW Permission for laying of 66KV underground cable line along NH-8 between Km 102+010 to Km 105+470, on RHS (From Fertilizer Nagar Sub-station to Ranoli substation) at Village Ranoli of Taluka & District Vadodara on Ahmedabad - Vadodara Section of NH-48 in the state of Gujarat.


