Sub: NHAI, PIU, Chennai – Permission for laying of OFC along the road from Km 276/240 to Km 276/440 (200 m) on RHS and from Km 276/440 to Km 284/000 (7560m) on LHS by Open Trench and HDD Method and across the road in one location at Km 276/440 by HDD Method in the State of Andhra Pradesh in Tirupathi -Tiruttani - Chennai section of NH-205 – Reg.

The proposal is regarding for laying of OFC along the road from Km 276/240 to Km 276/440 (200 m) on RHS and from Km 276/440 to Km 284/000 (7560m) on LHS by Open Trench and HDD Method and across the road in one location at Km 276/440 by HDD Method in the State of Andhra Pradesh in Tirupathi -Tiruttani - Chennai section of NH-205 submitted to this office by M/s. Telesonic Networks Limited., letter Ref: TNL/ROW/ P2/2021-22 /59_01 dated 29.04.2022 received by this office on 05.05.2022.

2. The details of proposal are as under:

a. The above proposal pertains to laying of OFC along the road from Km 276/240 to Km 276/440 (200 m) on RHS and from Km 276/440 to Km 284/000 (7560m) on LHS by Open Trench and HDD Method and across the road in one location at Km 276/440 by HDD Method in the State of Andhra Pradesh in Tirupathi -Tiruttani - Chennai section of NH-205. Further, HDD Method is proposed at all the cross drainage structures and the remaining location shall be carried out by Open Trench Method.

b. The width of Existing ROW is 60 m.

3. M/s. Telesonic Networks Limited., has furnished an undertaking to accept any claims raised by the Concessionaire/Authority if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
