**Invitation of public comments**

**Sub:** Relaxation of norms for the construction of an approach road & slab culvert for proposed retail outlet of BPCL at Km.(92.365-92.400) abutting on (RHS) road section of NH-130A Kh. No.22, PH.No.46, Village-Binouri, Tehsil-Takhatpur & Distt-Bilaspur, Chhattisgarh.

The CE (NH), PWD, Raipur vide letter no. 905/W/CE/NH/Raipur dated 04/06/2020 has submitted a proposal for NOC for the construction of an approach road and slab culvert in respect of retail outlet mentioned in the subject above. The applicant has sought relaxation from Ministry's norms stipulated in circular No.RW/NH-33023/19/99-DO.III dated 24.07.2013 for deviations in required distance from intersection with rural roads.

2. The Oil Company has requested for relaxation in view of para above. The justification towards relaxation is placed at Annexure-I.

3. As per Ministry OM vide No.RW/NH/33023/19/99-DO.III date 16.03.2016, the Highway Administration will make available the relaxation proposal of Oil Company for public comments, and the comments will be invited within 60 days from the day of uploading. Accordingly, the above relaxation proposal is being uploaded on the website of Ministry and Road Transport and Highways (www.morth.nic.in).



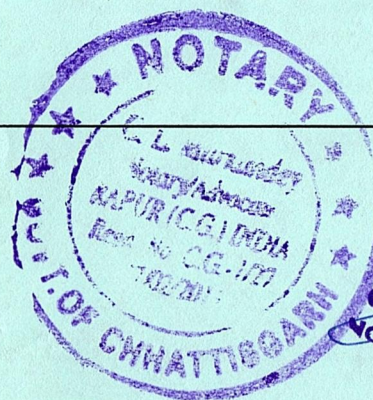

There is a 3.3m CC road at a distance of 117m going to basti on the same side of the plot. 2. There is a 3.7m BT road at distance of 268m going to village on the same side of the plot. 3. There is a 5.5m BT road at a distance of 260m going to village on the opposite side of the plot.	It is pertinent to mention that Oil Company has requested for relaxation of Ministry's norms in the instant case on the ground that: 1. Agency shall construct the required service road of 5.5m wide and 573m long followed by the 170m of A/D lane at their own cost and same shall be maintained by the agency only. 2. They have also agreed to provide separator and necessary safety equipments at their own cost. 3. Agency has also provided the Notarised undertaking regarding the construction and maintainence of service road & other amenities at their own cost. 4. Agency has also provided the Traffic Survey report giving the details of vehicle movements for the 7 continuous days.
