Sub: Four laning Madhya Pradesh / Maharashtra Nagpur section of NH-7 from km.652.00 (New km 653.225) to km.729.00, including construction of Kamptee – Kanhan & Nagpur Bypass and Maintenance of already, 4 landed section from km.14.585 to km.36.600 NH-7 (Nagpur-Hyderabad Section) in State of Maharashtra under NHDP Phase-II on DBFOT Basis – Permission of laying of electrical underground cable along NH-44 from km 725+455 to km 724+500 (RHS) and Crossing at 724+500 of Jabalpur – Nagpur of NH-44-Reg.

It is to inform all concern that M/s Maharashtra State Electricity Distribution Co. Ltd. vide letter under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU, Nagpur 1 has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/s Maharashtra State Electricity Distribution Co. Ltd. along on Jabalpur Nagpur section from km 725+455 to km 724+500 (RHS) on NH-44 in the State of Maharashtrais as follows:
 - Underground 33 KV Cable to be laid from km 725+455 to km 724+500 (RHS) along the Highway in utility corridor.
 - Cable to be laid with 4 Ducts in 1.20m below ground level.
 - Crossing at 724+500
 - Cable to be crossed by HDD method
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
