Invitation of public comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s HPCL at Km 95/117 to 95/144 (LHS) on NH-325 (Balotra-Jalore city road) at Khasra No. 695, at Jalore City, Tehsil- Jalore & District- Jalore in the State of Rajasthan.

M/s HPCL ie. the applicant vide letter No.JDRO/KKB/JALORE CITY dated 19.05.2020 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. The proposal was forwarded to EE PWD NH Division Barmer vide this office letter 21.05.2020 for comments and factual report. EE PWD NH Division Barmer vide letter No.98 dated 11.06.2020 has submitted the required report. There exists a intersection with any category of road (carriageway width of 3.5m and above) at 203m and 137m against 300m required as per MoRTH guidelines. However the proposed retail outlet proposal is submitted in this office with a provision to construct and maintain service of 5.50m wide and 213.0m long as per the proposed drawing. Service road will be constructed and maintained by Oil Company at their own cost. Undertaking for the same is appended with the proposal, therefore, this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per Form A (copy enclosed) on below mentioned address.
