Sir,

Bharat Petroleum Corporation Ltd. has submitted the proposal for access permission to the proposed retail outlet on NH-227A at Ch. 6+800(LHS) in Khata No.- 52, Plot no.- 26 & 27 at Mauza - Kelharua, Thana- Guthani, Dist.- Siwan in the state of Bihar through Executive Engineer, NH Division, Chapra, RCD Bihar vide letter no. 85 (WE) dated 06.02.2020 to this office.

2. The proposal has been examined as per Ministry's guideline dated 24.07.2013 & its subsequent amendments and it has been observed that plot of fuel station is 19.455 m away from centre line of road way. As per Ministry's guideline, plot of fuel station should be atleast 30 m away from centre line of road way in case of undivided carriageway.


3. BPCL vide letter no. MZP.NRO.Guthni dated 06.02.2020 has sought relaxation in norms as per Ministry's circular no.RW/NH-33023/19/99-DO III dated 16.03.2016 .

4. In this regard, objection of the public if any on grounds of public inconvenience, safety and general public interest, are invited on the subject proposal and hard copy of the same should reach to below mentioned address in the format as enclosed as Form-A within 60 days from the day of uploading, beyond which no objection will be considered.
