Sub: NHAI, Madurai Region - Highway Administration - Permission for laying of water Pipe line under PIU, Thanjavur - laying Water pipe line by EE, TWAD Board, RWS Division Thanjavur Laying of pipe along from Km 113+100 to Km 112+250-LHS, 117+600 to Km 116+438-LHS, from Km 116+438 to Km 115+250-LHS & from Km 115+260 to Km 114+500 and across at Km 117.600, 117+550&115+228 (Sethiyathope - Cholapuram - Thanjavur section) NH-45C Total Length 3960m in the state of Tamilnadu-Invitation of Public Comments - Reg.

The Proposal is regarding permission for laying of water supply pipeline from

- a. Along the road by open trench method in the following chainages:
- i. Km 113+100 to Km 112+250-LHS,
- ii. Km 117+600 to Km 116+438-LHS,
- iii. Km 116+438 to Km 115+250-LHS,
- iv. Km 115+260 to Km 114+500
- b. Across the road by trenchless method in the following chainages:
- i. Km 117.600.
- ii. Km 117+550
- iii. Km 115+228

The laying of water pipeline has been proposed in Sethiyathope - Cholopuram - Thanjavur section of NH 45C EE, TWAD Board, RWS Division Thanjavur.

2) EE, TWAD Board, RWS Division Thanjavur has proposed to lay the Water supply pipeline for a length of 3960 m along the edge of the ROW, at a distance of 1m from ROW edge and across the project at 03 location at a depth of 1.2m belong ground level. The proposal is in conformity with Ministry's guidelines vide letter No. RW/NH33044/29/2015/ S&R(R) dated 22.11.2016.

- 3) Further EE, TWAD Board, RWS Division Thanjavur has mentioned that the Water supply pipeline along the NH by Open Trench Method at a depth of 1.2m for along portion and by HDD at a depth of 1.20m for across portion.
- 4) EE, TWAD Board, RWS Division Thanjavur has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that EE, TWAD Board, RWS Division Thanjavur will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.
- 5) As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/ S&R (R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading.
