Invitation of public comments

**Sub: Proposal for grant of access permission to a new retail outlet of M/s HPCL on Udaipur to Ahemdabad road, NH-8 New NH-48 at km. 381+064 to km. 381+104 RHS, khasra no. 1008&998 of village - Rayna, Tehsil-Rishabhdeo, District - Udaipur in the State of Rajasthan.**

M/s HPCL ie. the applicant vide letter No. UDRO/AK/Rayna/Udaipur dated 05.12.2019 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. The proposal was forwarded to PD PIU NHAI Udaipur vide this office letter 13.12.2019 for comments and factual report. PD PIU NHAI Udaipur vide letter No.236 dated 12.06.2020 has submitted the required report. However the proposed retail outlet proposal is submitted in this office with a provision to construct and maintain of 7m wide service road of 41m and extra widening 159m long as per the proposed drawing. Service road will be constructed and maintained by Oil Company at their own cost. Undertaking for the same is appended with the proposal, therefore, this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways ([www.morth.nic.in](http://www.morth.nic.in)) or as per Form A (copy enclosed) on below mentioned address.
