Sub: Independent Engineer Services for four laning of Nagpur - Saoner - Betul section of NH-69 (New NH-47) from kms. 3.000 to km kms 59.300 in the State of Maharashtra and from kms 137.000 to kms 257.400 in the State of Madhya Pradesh on DBFOT (Annuity) Basis -Permission for laying of OFC-Reg.

It is to inform all concern that M/s BSNL vide letter under reference (ii) has submitted a proposal for the subjected work and PD, PIU-2, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- The alignment proposed by M/s BSNL, is along Nagpur-Saoner-Betul Section 2. of NH-47 in the State of Madhya Pradesh. The following work is involved:
  - Laying of underground Optical Fiber Cable from km. 70.770 to km. 71.200 and km 68.260 to km 68.470.
  - Alignment of the cable is along Nagpur-Saoner-Betul Section of NH-47
  - Caple to be laid in Duct 1.20m below ground level in utility corridor.
  - Caple to be crossed by HDD method
- As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
