INVITATION OF PUBLICE COMMENTS

Subject: NHAI, Madurai Region - Highway Administration - Permission for laying of water Pipe line under PIU, Karaikudi - laying Water pipe line by TWAD Board, Project Division, Karaikudi 63mm dia HDPE pipe Along the Road at Km 113/850 to 114/600 (LHS), 50mm dia HDPE pipe from Km.114/600 to km.114/780 (LHS) by open trench method & across the road at Km.114/600 by trenchless method in Thanjavur - Manamadurai road of NH-226 in the state of Tamilnadu - Invitation of Public Comments - Reg.

The Proposal is regarding permission for laying of water supply pipeline

- i. Along the road
 - i. 63mm dia HDPE pipe from Km 114/600 to Km 114/780 (LHS) by open trench method &
- ii. Across the road at
 - i. km. 114/600 by trenchless method of Thanjavur Manamadurai section of NH 226 TWAD Board, Karaikudi.
- 2) TWAD Board, Karaikudi has proposed to lay the Water supply pipeline for a length of 975 m along the edge of the ROW, which is at a distance of 14.5m from centerline of the project. The proposal is in conformity with Ministry's guidelines vide letter No. NHIII/P/66/76 dated 19.11.1976.
- 3) Further TWAD Board, Karaikudi has mentioned that the Water supply pipeline along the NH by Open Trench Method at a depth of 1.20m for along portion.
- 4) TWAD Board, Karaikudi has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that TWAD Board, Kariakudi will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.
- 5) As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments is invited within 30 days from the day of uploading. In
